1.	While it is not mandatory for me/us to send the original instruction to the Bank, should I/we choose to forward the original to you, it will be boldly marked with the following:		
	"EMAILED ON AVOIDS DUPLICATION".		
	The instructions transmitted by email will continue to be considered as confirmed instructions and will have the same legal weight and standing as the originals.		
2.	If for any reason or other, you acted on instructions sent through our email id email domain (company domain name) which were misused, or were sent by any unauthorized person, or if you do not receive the original of any email message or its attachments as above, and subsequently it is proved that this email or it's attachments is not sent by me/us, you will not be responsible for acting on this message and I/we will take full responsibility and liability for this, as this amounts to violation of my/our duty to exercise diligence and due care and to my/our agreement and undertaking with you as above.		

- 3. Acting by you on what may be photocopies emanating from the emails is fully binding on me/us even if you do not receive the original of the email authorization/ instructions.
- 4. You will not be held liable for any irregularity, delay, mistake or omission which may occur in the transmission of email instructions, or for the non-receipt of, or misinterpretation of the email instructions.
- 5. You are hereby irrevocably authorized to rely on email instructions as genuine, true and accurate reproduction of the original instructions and you shall bear no liability for acting thereupon and you are entitled to treat each email authorization/ instructions as fully authorized and binding on me/us and you are entitled (but not bound) to take such steps in connection with or in reliance upon such communication as you may in your sole and absolute discretion, deem appropriate.
